Under the Articles of Association of the Illinois Coal Association, the Board of Directors have adopted the following terms and qualifications for admitting Associate Members to membership in the ICA.

Associate Members may be any firm, business or corporation which has an interest, direct or indirect, in the Illinois coal industry (reserve holders, land companies, coal processing and sales companies, equipment manufacturers and distributors, railroads, water carriers, trucking companies and others involved with the transportation of coal, mine service, supply or maintenance firms, engineering and other professional and consulting services).

Associate Members shall have no right to vote upon any matter affecting the management or other business of the Association. However, Associate Members may request to serve on Association Committees as non-voting members, contingent upon approval by the ICA President and Chairman of the Board of Directors.

Associate Members may designate representatives of its company to receive mailings and emails sent by the ICA.
